This form must be used to apply for a licence if any of the following statements apply to your situation:

- a) Have you passed the OACIQ certification exam? In accordance with Regulation respecting the issue of broker's and agency licences, you must have passed the OACIQ certification examination no more than 12 months before the licence application.
- b) You are a former OACIQ licence holder and your licence has been revoked following, for example, the non-payment of the annual licence maintenance fees? You have 12 months following the revocation date to apply for a licence without having to complete a recognized basic training program and pass an OACIQ certification exam again, provided that you have completed the previous cycle of the Mandatory Continuing Education Program (MCEP) which has ended since that date.
- c) You chose to stop carrying out brokerage activities for a while and maintained your acquired rights annually? Acquired rights gives the possibility of obtaining a licence of same category without having to successfully complete a recognized basic training program and pass an OACIQ certification exam again. If you wish to return to the real estate brokerage practice, you must first meet the requirements of the Refresher Training Program for the MCEP cycles that were in effect during your acquired rights period. Read **this article** for more details. You must then complete this form, 12 months after your licence revocation date at the latest.

The total amount of applicable fees varies depending on the month in which you wish to start or resume your practice. Read **this article** for more details.

If your criminal record check was carried out less than six months ago, we will refer to the previously obtained results and no email will be sent.

This check will enable us to validate the compliance of the declarations you made in this form under the "Declarations" section and to determine whether a further examination of your file by the Licence Issue and Maintenance Committee (LIMC) is justified.
